



**TENNESSEE AFTRA/SAG REGIONAL CONTRACT**  
**2006 Extension to the 2003 Contract**

**SECTION 1 - SIGNATORY STATUS**

It is understood and agreed that any and all signatories to this Tennessee Regional Contract shall be bound to the terms and conditions of the 2006 Extension to the 2003 Screen Actors Guild Television Commercials Contract and to the the 2006 Extension to the 2003 American Federation of Television and Radio Artists Television and Radio Commercials Contracts. It is further understood that all terms and conditions of the aforementioned AFTRA and SAG National contracts shall apply to all commercials produced on or after October 30, 2006, except for those specifically modified and expressed in this 2006 Extension to the 2003 Tennessee Regional Contract.

**SECTION 2 - JURISDICTION**

The AFTRA Tennessee Regional Contract shall apply to radio and television commercials produced within and limited to use within the state of Tennessee. The SAG Tennessee Regional Contract shall apply to television commercials produced and limited to use within the states of Tennessee and Kentucky.

**SECTION 3 - TERM AND EFFECTIVE DATE**

This Agreement shall become effective as of October 30, 2006, and shall apply to all productions made during the term of this Agreement. The expiration date of the Tennessee Regional Contract shall be co-terminus with the 2006 Extensions to the National AFTRA and SAG 2003 Television Commercials Contracts and the 2003 AFTRA Radio Commercials Contract, or October 29, 2008, and shall continue in effect until terminated by either party 60 days notice in writing to the other.

**SECTION 4 - TENNESSEE REGIONAL RATES**

The minimum rates for all productions under this contract which are produced in and for use within the jurisdiction as named in Section 2 shall be 75% of those found in the 2006 Extensions to the 2003 AFTRA and SAG Television and Radio Commercial Contracts.

All other terms and conditions as found in the 2006 Extensions to the 2003 AFTRA and SAG Television and Radio Commercial Contracts shall apply to commercials produced under this contract.

**SECTION 5 - HEALTH AND RETIREMENT AND PENSION AND HEALTH CONTRIBUTIONS**

Health and Retirement and Pension and Health contributions shall be made in accordance with the provisions contained in the 2006 Extensions to the 2003 AFTRA and SAG Television and Radio Commercial Contracts in an amount equal to 14.8% of all gross compensation.
