

THE UNFAIR LIST

THIS LIST is comprised of Guild-signatory producers who have either 1) been found by a neutral arbitrator or court to have violated one or more of the Guild contracts; or 2) have defaulted on payments to performers during production and have had production halted pending full payment. We encourage performers who may be employed by one of the listed producers and the agents of such performers to negotiate additional personal financial assurances with the producer, such as creating an escrow account for the salary a performer expects to be paid by

the producer. For various reasons, some producers who fit the above criteria may have been omitted from this list. Performers should always check with the Guild prior to agreeing to accept employment with any producer.
